RESOLUTION OF THE TOWN BOARD OF THE TOWN OF MONROE AUTHORIZING THE TOWN SUPERVISOR TO EXECUTE THE 2021-2023 COLLECTIVE BARGAINING AGREEMENT BETWEEN

THE TOWN OF MONROE AND IBEW LOCAL 363 RELATING TO THE TOWN OF MONROE
HIGHWAY DEPARTMENT

WHEREAS, the Town of Monroe and IBEW, Local 363 (Highway Department) had previously entered a Collective Bargaining Agreement that expired on December 31, 2020; and

WHEREAS, the parties had entered into collective bargaining negotiations for a successor agreement; and

WHEREAS, on October 7, 2020 the members of the IBEW (Highway Department) met and ratified the proposed terms of the new Collective Bargaining Agreement.

NOW, THEREFORE, it is resolved by the Town Board as follows:

Section 1. All WHEREAS paragraphs are incorporated herein by reference as though set forth in full herein.

Section 2. The Town Supervisor is hereby authorized to execute the annexed Collective Bargaining Agreement between the Town of Monroe and the IBEW Local 363 relating to the Town of Monroe Highway Department, effective January 1, 2021, through December 31, 2023.

Section 3. The Town Clerk, Town Comptroller and any other Town officials and/or employees are authorized to take any necessary actions, as directed by the Supervisor, to carry out the provision of this Resolution.

Section 4. This Resolution shall take effect immediately.

RESOLUTION AUTHORIZING TOWN SUPERVISOR TO EXECUTE MEMORANDUM OF AGREEMENT WITH TEAMSTERS LOCAL 445 DIAL-A-BUS BARGAINING UNIT ESTABLISHING AGREED UPON TERMS FOR A SUCCESSOR 2020-2022 COLLECTIVE BARGAINING AGREEMENT

WHEREAS, the CBA between the Town of Monroe (Town) and the Teamsters Local 445 on behalf of the Towns Dial-A-Bus Union (Union) expired on December 31, 2019 and the parties subsequently participated in negotiations for a successor CBA; and

WHEREAS, the Town and the Union engaged in negotiations and agreed upon terms and conditions for a successor CBA as annexed hereto; and

WHEREAS, the Town and the Union desire to enter into a Memorandum of Agreement (MOA) for the period January 1, 2020 through December 31, 2022

NOW, THEREFORE, BE IT RESOLVED that:

Section 1.The above WHEREAS clauses are hereby incorporated by reference as though set forth in full herein.

Section 2.The Town Supervisor is hereby authorized to execute the MOA between the Town and the Union substantially in the form annexed hereto.

Section 3.The Town Supervisor and any employee or official as directed by the Town Supervisor are authorized to take any and all necessary actions to carry out the provisions of this Resolution.

Section 4.This Resolution shall be effective immediately.
